SUBJECT : **Initial Designation of Zamboanga City Airshed**

Pursuant to Section 9 of the Philippine Clean Air Act of 1999 (RA 8749) and Section 1 to 11, Rule XV, Part V of its Implementing Rules and Regulations (DENR Administrative Order 2002-81), the following barangays/areas are hereby designated initially as Zamboanga City Airshed:



This designation is based on the initial characterization of Zamboanga City showing the same to have complied with the criteria set forth under Section 2 of DAO 2000-81.

Further and pursuant to Section 1 and 2, Rule XV, Part V of DAO 2000-81, upon consultation with appropriate local government authorities, the Secretary of the Department, upon recommendation of the Bureau shall, from time to time, revise, the designation of the airshed utilizing eco-profiling techniques and undertaking scientific studies.

This Circular takes effect immediately and shall remain in force unless repealed or revoked in writing.
